

FINAL PLAT

APPLICATION OVERVIEW AND SUBMISSION MATERIALS

A Final Plat application will be reviewed in accordance with the procedures and requirements as outlined in Chapter 17, Article 3, of the Edgewater Municipal Code.

The City of Edgewater's Municipal Code, Chapters 17, can be found online at the following website address: (https://www.municode.com/library/co/edgewater/codes/municipal_code?nodeld=18011).

Final Plat applications are presented to Planning Commission for a decision. Upon approval by Planning Commission of a final plat, it shall then be presented to City Council for its approval and acceptance of the areas dedicated to public use.

FEE

A non-refundable fee is required and is to be paid once an application has been submitted. A development review deposit may be required.

ALL PLANNING APPLICATIONS ARE ACCEPTED THROUGH EDGEWATER'S ONLINE PORTAL.

Note: The Final Plat shall conform substantially to the preliminary plat as approved, and it may constitute only a portion of the preliminary plat which the subdivider propose to record and develop.

USE THE CHECKLIST BELOW AS A GUIDE OF ELEMENTS TO INCLUDE IN YOUR APPLICATION
☐ Title Commitment (must be current within 6 months) showing current ownership
Letter of Intent that includes a project description.
☐ Certified and Stamped Survey of Property with size 24" x 36"
☐ One set of Stamped Envelopes and written list of all adjacent property owners names and addresses. Stamped envelopes must be addressed to all adjacent property owners.
"Adjacent properties means properties that share a common lot line or any single point of their respective lot lines, as well as properties separated by a public street or alley, and properties situated diagonally from the subject property, even where separated by a street or alley, which would otherwise be adjacent to the subject property."
Letters of Agreement between the applicant and all electrical and natural gas utility providers that will serve the development, or other evidence satisfactory to the City that provision has been made for the facility sites, easements and rights of access to ensure reliable and adequate electrical service and, if applicable, natural gas service for the proposed subdivision.

	The date, title, name and location of the subdivision, graphic scale and true north line. All dimensions, angles, bearings and similar data on the plat should be tied to primary control points as
	approved by the City. The location and description of said control points should be given. Tract boundary lines, right-of-way lines of streets, easements and other rights-of-way, and property lines of residential lots and other sites, with accurate dimensions to the nearest one-hundredth (1/100) of a foot; bearings or deflection angles, radii, arcs and central angles of all curves and dimensions on the centerline of all proposed streets shall be shown.
	Street names and right-of-way width of each street, easement or other right-of-way.
	Lot and block numbers. Names and locations of adjoining subdivisions and streets.
	Required certifications and approvals blocks, as shown on subsequent pages of this packet. Approval blocks are to be included on the cover sheet of the Final Plat plan set.
	The final plat submitted for recording shall be drawn in permanent ink on Mylar film with outer dimensions of twenty-four (24) inches by thirty-six (36) inches.

	Copy of Condominium Association Articles of Incorporation and bylaws.
