Details

On Thursday, December 28th, at approx. 5:05 p.m., calls were received of shots being heard in the 2400 block of Kendall Street in the city of Edgewater. As Edgewater Police Officers responded to the scene, additional information was being received that multiple residences and parked vehicles had been struck by gunfire. Witnesses advised that a male subject had fled the location on foot.

A short time later, calls were received from the 1800 block of Fenton Street advising of additional shots heard and that a male subject had attempted to steal a vehicle. The subject was interrupted by a female resident and her 13-year old daughter and the subject pointed a gun at them before fleeing on foot. As an Edgewater Police Officer arrived in the area of Fenton Street, he observed a male subject running toward an occupied apartment building with a semi-automatic handgun in his hand. The officer initiated a foot pursuit of the subject who ran towards bystanders on the sidewalk. The subject eventually dropped his handgun and was safely taken into custody. He was later identified as 19-year old Denver resident, Isaac Frank Guillen. A loaded .40 caliber semi-automatic handgun was recovered from the location where he had been seen dropping it.

Investigators are still unclear as to the motive for the number of shots that were fired in the 2400 block of Kendall Street. Guillen appeared to be intoxicated at the time of his arrest and has prior arrests that prohibit him from possessing a firearm. The Edgewater Police Department is thankful for the numerous residents that called in and provided valuable information to assist with the capture of Guillen. We are particularly grateful that nobody was struck by gunfire during this incident.

Guillen was later arrested and transported to the Jefferson County jail on the following charges:

Menacing (Deadly Weapon) (X2 Counts)	(F5)
Illegal Discharge of a Firearm (X10 Counts)	(F5)
Aggravated Motor Vehicle Theft	(F5)
Possession of a Weapon by Previous Offender	(F5)
Prohibited Use of a Weapon (Intoxicated)	(M2)
Resisting Arrest	(M2)
Obstructing a Peace Officer	(M2)
