Urban Forest Master Plan

Presentation by Davey Resources Group / Board impression and discussion on public feedback of draft

Intro: Sam Heywood (Davey):

- Placeholder pictures still in Report
- Prioritize planting can happen in many ways a few options listed in plan, we can decide
- No apples to apples comparison of 2011 vs 2017 analyses for tree canopy

Recommendation A

- Increase transparency, public awareness
 - In progress brochure ready to go out: how to plant trees, care for tress and who is responsible
- Educate community in effective planning and care
- Revise Healthy Tree Canopy Program
- Lilly confusion about residents knowing that they are responsible. Need to know responsibilities were existing, not new to this plan. Call out appropriate ordinance.
- Jeannette "refreshing the community on this" help you learn how to best care for your trees. Public awareness. Community/family.

Recommendation B

- Acknowledge WELC updates
 - Continue momentum to protect trees on public land
 - Program to proactively enforce public tree maintenance
 - Already an ordinance, how to make people aware it is their responsibility?
- Establish replacement requirements for removal of public street trees
- Improve consistence and coordination of private tree care company business license requirements
- Jeanette do people know what is a public vs private tree?
 - Public tree inventory should be hosted publicly?
 - ROW is boundary
- Contact people after tree inventory is complete
- Feedback loop to citizens, from arborist, when things have played out in understandable bits
- Xerxes this one is on the city. Rec A is more about community engagement.
- Jackie how to get this information into the hands of the right people. Multi-channel? Bigger communication plan? Not a problem isolated to this plan overall community engagement issue.
- Andy do we define what an action item is, how does it function toward implementation of this document. Not in code yet, people can still be involved as new code/policy is developed.
- Davey interest will grow as communication increases. Will get more people engaged
- SOPs Process to improve comms, collaboration among city staff
- Identify Key staff
- Explore incentive programs
- BMP Know what it means, outside expertise needed
- Ensure urban Forest considered with all future capital infrastructure projects
- Jeannette will we be coordinating so people know who does what?
 - Identify key staff action item.
 - \circ $\;$ Are there motivated people on staff ready to implement action items?
 - Jocelyn: SB will recommend on final draft (future meeting), plan goes to CC, they make final adoption of UFMP. Once adopted, this is work plan for all city staff. Depts develop implementation plans based on est timeline, which dept involved etc. Train Staff? Community engagement?
 - Xerxes: Capital infrastructure: does this need new policy? Jocelyn: SOPs will help. New policy direction if needed.
- Lilly: Considered in capital projects: spelled out a lot better. Replaced trees are small when replaced in capital projects. Details time for replacement, what replacement value looks like (eg: size/diameter, species) all needs to be better defined. This one should be fleshed out more. Andy agrees.
 - Sam: these are shorted due to space in this presentation. Some more detail in full plan.
 - Lilly: this item lacks strength to get to ordinance. "Considered" is too contemplative eg: no trees currently, so no need to consider future trees. Stronger in stating that trees need to be part of all plans, rather than just "considered." Ensure it is "supported"?
- Andy: incentives. Neglects current system for current property owners. Making sure we are providing for existing, not just new property/projects. Somewhat addressed in A (Build/fund Healthy canopy program).
 - Dana: Change in ordinance is an outcome, not necessarily within this plan. Not usually in plan.
 - Jocelyn: council develops policy, staff implements.
 - Dana: canopy is big trees, need to plant little trees and care for big trees.
 - Andy: should we explore incentives for private trees, too? Many of our large trees are on private property.
 - Xerxes: need more actionable items than "explore" incentive programs. Review, explore and revitalize (more actionable)

Recommendation C

- Educate staff
- Mirror improvements to ordinance and procedures
 - Consultants, staff? Enforce.
- Train staff on rules
 - o Enhances public education
- Support staff in training opportunities in urban forestry training
- Jocelyn: should things be both "short term and ongoing" training shouldn't be one and done
- Xerxes: should there be a full-time staff member? In-house expertise. Would you make that recommendation
 - Sam: be careful about saying adding more staff. Procedures and goals should drive staff decisions. This does demand attention, though.
 - Dana: difference between arborist and urban forester. Cares for trees vs managing forest. Individual vs whole community of trees.
- Do other cities have forestry yes, Denver, Wheat Ridge and Lakewood do. Larger communities do, smaller not as much.

Recommendation D

- Regularly update UTC assessment (schedule)
 - Next in 2027. Maybe earlier pending available data
 - Utilize UTC to develop overall canopy goal
 - Canopy goals should be based on science can't plant where you can't plant
- Conduct tree inventory
 - Managed by certified professionals to ensure accuracy size, health maintenance needs (Denver has, WR has)
- Develop management plan based on inventory data
 - Plan for trees, work plans, address priorities more granular than Master Plan
 - Who needs to approve trees
 - \circ $\;$ Identifies budget and funding needed who to partner, who staff
 - o Identifies gaps
 - Disaster storm/response
- Strategy to assess budget needs
- Site analysis for public planning efforts
- Xerxes: we have data on tree loss use that as motivator to get people to engage. Address up front
 - Sam: 2013 conducted by state. Wasn't the same methodology/scope as 2020 harder to compare.
 - Xerxes: we know we've lost trees. Why isn't this mentioned at the beginning. Key motivator is to grow canopy. Connect to vision – should be where we want to go, not where we are. Vision and motivation needs to push people to plant more trees. Lost more than 1/3 of canopy.
 - Sam: Need to lean more into theme of canopy loss. More forward-looking tone to vision statement. Doesn't have to be numbers.
 - Lilly: studies aren't good matches for each other?
 - Dana: Good studies, but numbers should be taken with caution (state/federal) old, not good data. Lost 30 acres on trees (6 acres/yr) 1800 trees lost during period. Seems like too much didn't feel like this was good science/comparison. Communities now are trying to run same process for each study. Not done badly persey, but it is out of date and done differently.
 - Sam: expand on previous canopy studies used what was provided. Highlight as part of the plan – center around methodology (eg: were shrubs included). Studies are analyzing pixels – how was this determined. AS methodologies change, comparisons are harder.

- Xerxes: should we include recommendation on methodology? So we don't do this again?
- Benchmarks in ops review. See where performance levels should be use those. Use tree canopy, UTC studies? This is the "where should we be" Can this help with engagement know we are hitting goals, what are they, how can I be a part of a winning team.

Recommendation E

- Identifying area for planting and number to plant per year
 - Educate residents on species that are tolerant and thrive
 - Right tree right place right time
 - o Est tree planting permit
 - \circ $\;$ Ensure planning recommendations work in existing docs
 - \circ $\;$ Explore ways to increase canopy on private property
 - Lilly: funding lens we are on the underfunded side. Are there areas for grants?
 - Dana: IRA money coming out next Fri. Underserved communities. We fit. Talk to staff.
- Xerxes: Develop overall canopy goal. Driver of everything. Needs a number? Eg: set a goal to grow canopy to 2011 levels.

Recommendation F

- Coordinate with bordering stakeholders
 - Large and small communities
- Share services and equipment with neighboring communities
- Utilize county, state, national resources
 - o Toolkits

- Great document. Clear. Appendices are helpful. Excited to see the future.
- Pg 42: Table 5 Funding is going down for Healthy canopy. Math issue? Or are we losing funding? Staff to look into.

Thea

- No background. Found it overwhelming. Need to pare down, with concise wording to make more accessible help with education.
- Needs sense of urgency. Compact action plan.
- What are financials involved in enforcement? Vs rewarding for planting? Carrot vs Stick.

Xerxes

- Approachability this was written for staff to implement, not necessarily for citizens. Need version for public facing.
- Executive Summary should be for decision maker to get the gist and decide. Shouldn't read like an intro, should summarize key findings and action items. Needs to motivate.
- Tree Advisory Committee is there a recommendation for how this cttee might go about growing urban forest canopy and awareness of it?

• Committees are all over the map. Go with the culture of the community. As things grow and happen, need to find niche. All kinds of roles.

Lilly

- Sustainability Board Tree funding went to branch/storm clean-up? Jocelyn agrees, staff to dive in
- Pg 66: Typo? HOW do we get there!

City Cost Recovery Strategy and Seminar Series Fee of \$3

See excerpt of COE's cost recovery program approach in agenda packet

- Decided by city staff leadership in Fall 2023
- Staff: Pilot for the year, applies to the Sustainability Series. Could restructure so we charge only for seminars where city has to pay for the facilitator
- Jeannette: try things out, see how it goes.
- Lilly: feedback. \$3 isn't a big amount. They just want to come, creating account to pay was a barrier. Time vs money.
- Andy: concerns about charging. We would only be recouping \$30. Isn't there a line item for education. Tree plan – educational opportunities to plant trees, requiring to pay for info feels wrong. Goes against small town/community feel. What is our budget? Can Board use those fees to cover (response: it's all city budget – we're honoring Council directive).
- Xerxes: charge for workshops as cost recovery model vs purely educational seminar.
- Courtney: want people to be able to show up at the last minute, stay when they want. Don't want to prevent people from coming.
- Jocelyn: Agree. Staff may not have brought Sustainability Board into conversation. This fee isn't specific to Sustainability Board. Part of the intention is to prompt staff and boards to seek out sponsorship and other opportunities to cover costs

COE Cost Recovery Model and Strategy

Excerpts taken from the Parks and Recreation Department's Financial Policy Updates presentation to City Council in September 2023, which then revised and adopted the measures in in Q4 2023 for implementation in January 2024.

Purpose

- Create organizational resilience and financial stability.
- Implement revenue generation strategies that are fair, equitable, and responsible.
- Utilize consistent subsidy and cost recovery strategies across City departments.

History

- 2010: First implemented by Edgewater Parks & Rec Department as *Fee Structure Guidelines*.
- 2011-21: Used to guide fee structure for programs, rentals and contract instruction parameters
- 2022-Present: Staff education on changes in best practices around pricing, cost recovery and subsidy, and revision of *Fee Structure Guidelines* to encompass all *Parks & Rec Financial Policies*

Service Category:

• Education and Enrichment

Impact

- Keep up with increased costs and demand for services without placing strain on the overall City budget
- Encourages staff to be creative in funding streams

- Expanding sponsorship opportunities
- Engaging in partnerships

Needs Based Assistance

- Updates the SMILES program to CREATE
- Makes financial assistance available to all Edgewater community members.
- Annual discount based on HUD research, 25-50-75%.
