- a. Vote on Urban Forest Master Plan recommendation to City Council
 - i. Final version and standalone Executive Summary now available
 - ii. Scott motioned to vote on recommending the UFMP to the city council. JP seconded.

- b. Sustainability Board participation at the Grand Opening on June 15th at Citizen's Park
 - i. Tree Planting at 10:00am (Event is from 9AM 1PM, tree planting will actually begin at 10:30)
 - 1. 2 trees will be pre-planted (1 as a memorial, 1 for Bill Cassel's retirement)
 - 2. 3 Speakers: 1 from employee's family, 1 city staff person for the retirement, 1 sustainability board member commemorating Arbor Day
 - a. Jaclyn Poliseo will speak on behalf of the board and will receive suggestions for remarks from other board members
 - ii. Tabling and LED Kit giveaway at 11:00am
 - 1. Promote Sustainability programs, collect emails, etc.
 - a. Courtney will staff the table from 11-12, Jaclyn will be available from 12-1; Shaima will be present from 11-1
 - iii. Sustainability Board can reach out to Sustainability Ambassadors regarding the Grand Opening event and activities
- c. Sustainability Plan Update
 - i. Discussion on the process
 - 1. Sustainability Board could lead the plan update instead of fully outsourcing to a third-party contractor
 - 2. Category leads will lead drafting and updating of the plan's goals associated with their resources.
 - 3. Board will plan meeting to workshop sections of the plan. Afterwards, public input meetings can be planned to allow public ownership of the document.
 - 4. A third-party facilitator could be used for partial support including a public/community outreach plan, plan facilitator/project manager, and a Carbon Inventory update
 - 5. The updated plan will have to go through City Council and require a new city ordinance.
 - 6. The Board will consider an RFP or process for securing contractors capable of filling the scope.
 - 7. Jocelyn Mills noted a budget of \$50,000 \$75,000 for the Sustainability Plan Update.
- d. August Retreat

- e. Seminar Series Scheduling Update
 - i. 9 participants in May's Basics of Organic Gardening by Denver Urban Gardens
 - ii. Facilitators still needed for July, September, November, December
 - iii. Intro to Xeriscaping could be considered as the seminar for July. Board will brainstorm ideas for other seminars and facilitators.

- iv. For Drive and Ride, the Board should consider a weekend in early/mid November during the day to make the event more accessible for families.
- f. Update on Solar United Neighbors contract and challenges with Nelnet
 - i. The Public has voiced concerns and difficulties with Nelnet installation services and permitting setbacks. Nelnet and Solar United Neighbors have distributed instructions and talking points to assist participants who are having issues.
 - ii. The City of Edgewater is reconsidering its contract with Solar United Neighbors to ensure services are being rendered. Renewal of contract is on pause.
- g. Partners in Energy
 - i. Home Energy Squad
 - 1. Review of 2023 outcomes / Main takeaways from the Year End Dashboard (see summary in packet, below)
 - Residential participation is doing great. Participation has been generally increasing since 2019. 2023 is comparable to 2022 participation. Continued engagement with residential customers will likely keep participation up.
 - b. Commercial and Industrial (C&I) participation was a huge savings contributor from 2020-2022 but dropped off significantly in 2023: 2020 – 2022 the bulk of savings came from C&I participation (most noticeable on pg 3). Reengaging with C&I customers could help increase impact.
 - c. Municipal participation is low for all years. Engaging more municipal participation would increase impact.
 - 2. Contract renewal
 - a. Continued partnership and promotion of this program is planned so that the community is aware of and able to take advantage of it
 - b. Board ideas around how to spread the word are always welcome
 - c. Standard visits are now free and Plus visits are discounted
 - 3. Sustainability Board should consider having a Xcel representative present the home energy squad's services
 - 4. The Board should consider an inventory of municipal, industrial, and commercial buildings who have undergone an energy audit to target focus
