RE: Zoning and Subdivision Code Update/RFP discussion

The purpose of the worksession is to begin brainstorming options for what to include in the forthcoming Request for Proposal (RFP) and scope of work to update Edgewater's zoning and subdivision codes.

Questions for discussion:

On process.

- Does the commission want to establish a steering committee of community members and the commission for the code update process? Or have the commission itself be the steering committee?
- Do you have any community engagement guidance you want to make sure is included in the RFP for the code update? (We will want to include it is in both English and Spanish.)
- Anything from the Comp Plan update process you want to see included in this process?
- Any other thoughts on the update process?

On Direction for Update.

- Do we want to ask that consultants provide outline on how to do the project? Or do we want to indicate we want to see update completed in three phases: Sheridan corridor/20th Ave Commercial areas, 25th Ave Commercial Core and Residential Neighborhoods.
- Do we want to include as a second task review and update of the design guidelines we have in place for the City's commercial corridors?

General & Selection questions.

- Anything you particularly like about the example RFPs that you want to include in the code update process?
- For the selection process, do you want staff to bring all RFPs to the commission or do you want to have two of you work with staff to vet down to 2 or 3 finalists and bring those for interviews before the Commission?
- What other questions come to mind?

Next Steps:

Staff will take the commission comments and draft an RFP for the code update project and bring a draft back for the commission to review at the next meeting in November.

Tentatively, the timeline will be to post the RFP in January for a month, and then to have interviews before the commission in March with a recommendation to Council on a firm in April. A tentative project start time is May, 2025.
